# March 26 - 30, 2015

## STREET CLOSURES SCHEDULE:

The following streets will close on <u>Thursday, March 26<sup>th</sup>:</u>

Approximately 7:00 a.m. Closure (Peripheral Street & Lot) -

- 7<sup>th</sup> Street between Mill Avenue and Maple Avenue
- 440 South Mill Surface Lot (between Hackett House and Mill Avenue Shops)

Approximately 4:00 p.m. Closures (Peripheral Streets; In Order of Closure) -

- 6<sup>th</sup> Street, from Mill Avenue to W/6 Tower 2 Entry Roundabout
- Maple Avenue, from 5<sup>th</sup> Street to 7<sup>th</sup> Street

Approximately 5:00 p.m. Closures (Peripheral Streets; In Order of Closure) -

- 4<sup>th</sup> Street, from Mill Avenue to Maple Avenue
- 5<sup>th</sup> Street, from Mill Avenue to Ash Avenue
- 5<sup>th</sup> Street, from Mill Avenue to Myrtle
- 6<sup>th</sup> Street, from Mill Avenue to Sixth Street Park
- 7<sup>th</sup> Street, from Mill Avenue to Myrtle
- Maple Avenue, from 4<sup>th</sup> Street to 5<sup>th</sup> Street
- City Hall West Parking Lot

Approximately 6:30 p.m. Closures -

• Mill Avenue, from University Drive to 3<sup>rd</sup> Street

All Streets should re-open by 6:00 a.m. on Monday, March 30<sup>th</sup>.

### DELIVERIES FOR DOWNTOWN TEMPE BUSINESSES:

• Downtown Tempe Authority Safety Patrol will notify merchants of delivery requirements and will secure signatures from whoever receives the information for each business to assure that we have reached everyone.

- We permit delivery entry ONLY at 5<sup>th</sup> and Ash (the west end of 5<sup>th</sup> Street). <u>No deliveries</u> will be allowed to enter from the East on 5<sup>th</sup> Street, and none on the North or South on <u>Mill Avenue</u>.
- Deliveries will be permitted throughout the night beginning at approximately 11:00 p.m. on Thursday, March 26<sup>th</sup>; and 9:00 p.m. on Friday, March 27<sup>th</sup>; Saturday, March 28<sup>th</sup>; and Sunday, March 29<sup>th</sup>.

### • <u>All trucks must vacate the event area BEFORE 9:00 a.m. each day of the Festival</u>.

• Should your deliveries not arrive before 9:00 a.m., please contact DTA Operations Hotline at **480-894-1800** and we will determine the alternate load-in options available so that delivery can be accommodated, if possible.

If not possible, there are locations just <u>outside</u> the Festival's perimeter barricades where FedEx and UPS may park and hand-load deliveries throughout the day. Barricade entry is not permitted during open hours to the public; however, FedEx and UPS can stop and hand-truck deliveries at the following locations:

- 7<sup>th</sup> Street, east of Mill Avenue
- 5<sup>th</sup> Street, west of Mill Avenue entering from Ash
- 5<sup>th</sup> Street, east of Mill Avenue entering from Myrtle
- 3<sup>rd</sup> Street loading zones between Mill and Ash
- <u>In no event will deliveries be allowed after 9:00 a.m. on any day of the festival</u> except for U.S. Post Office deliveries which may require special arrangements.
